1. KU Study Approval

5. Performance Indicator 11

We have received each district's results on State Indicator 11 (child find for early childhood). Rhonda Denning shared the results, explaining that each Keystone district met student's needs and students were placed appropriately.

6. Grant Update

A draft report of current grants was shared with the Board. Linda Kilgore will add a timeline, do some minor modifications, and continue to keep this information updated to share with the board members.

7. Board Planning

Tim Marshall presented results from the Keystone 'Advance' planning session to the board. The board and superintendents strengths and needs matched the Mission and Vision of Keystone.
